### PARK USE

Reserving the park does not exclude party from being subject to park rules set forth as follows:

### REGULATIONS

**Non-exclusivity:** Fort Street Bridge Park is public and open to the public during hours of operation. As such, use of the park is not guaranteed to be exclusive.

**Hold Harmless, release, and waiver:** To the fullest extent permitted by law, all users of Fort Street Bridge Park waive, release, and forever discharge and hold harmless Downriver Delta CDC for any and all liability, damages, any and all claims, causes of action, demands of whatsoever kind or nature, or loss, including all costs connected therewith, and for any damages that may be asserted, claimed or recovered against or from Downriver Delta CDC, its board members, or employees, by reason of personal injury, including bodily injury or death and/or property damage including loss of use thereof, which may arise as a result of acts, omissions, faults and negligence directly or indirectly from my activities.
